Further, in section-38 (special provisions for persons with disabilities with high support); section-41 (Access to transport); section-42 (Access to information and communication technology) and section-43 (Consumer goods-measures to promote development, production and distribution of universally designed consumer products and accessories for general use for PwDs) the provisions regarding research and development of Assistive technology and assistive devices are mentioned in the RPwD Act, 2016.
