- 7. It is worth mentioning here that your corporation did not avail any funds against the notional allocation of last financial year (2018-19). Infact, your Corporation is yet to start the implementation of NHFDC scheme. The SCAs are required to furnish utilization of these funds in the prescribed format within 90 days of release of funds.
    - 9. In view of the above, SCA is requested to send a duplicate copy of this letter, within 15 days from the date of issue of this letter, duly signed by authorized signatory of the organization on each page, as token of acceptance of the notional allocation. SCA may also send request for release of 50% out of the above allocated funds as advance funds, if required or else SCA may seek funds in reimbursement mode.

On receipt of the duly signed copy from your corporation, NHFDC will consider release of 50% notional allocation as advance to implement projects costing upto Rs.10.00 lakhs by BCBCFDC.
