**Misc. Order No. 67 of 2020.**

As per office Misc. Order No. 142 of 2019 dated 17.10.2019, the Court of 15<sup>th</sup> Addl. District & Sessions Judge, Rohtas, Sasaram (i.e. the Court of Junior most Addl. District & Sessions Judge in Sessions Division of Rohtas at that time) had been designated as Special Court for the purpose of trial of all offences under The Right of Persons with Disabilities Act, 2016 in the light of Notification issued by the Law Department, Govt. of Bihar, Patna as contained in memo No. A/Act-07/2017/7369/1 dated 14.10.2019.

But presently the Court of 21<sup>st</sup> Addl. District & Sessions Judge, Rohtas, Sasaram presided over by Sri Amit Raj is the Junior most Court at this station.
